**Juror Scott Malbaurn:** Prior to his appointment as Director of Southern Oregon University's Schneider Museum of Art, Malbaurn was the Acting Assistant Chairperson of Fine Arts at Pratt Institute in Brooklyn, NY and oversaw the undergraduate Fine Arts program in the areas of drawing, painting, printmaking, sculpture, jewelry and ceramics. Malbaurn also worked at the Isamu Noguchi Foundation and Garden Museum located in Queens, NY where he worked in the Curatorial and Collections Department as well as Noguchi's Design Department. Malbaurn has an extensive background in independent curatorial work in New York and has had his own work displayed in many professional exhibitions nationally and internationally. Malbaurn was also co-owner and curatorial director of the H. Lewis Gallery in Baltimore, MD. He has also taught drawing courses for Southern Oregon University.

**Cash Awards: \$1,000 1st Place, \$500 2nd Place, \$300 3rd Place, \$200 J. Lynn Peterson – Hundred Valleys Award.**

Eligible to all artists working in the Pacific Northwest to submit up to (5) entries in all themes and genres. All work must be display-ready upon arrival. UVAA commission rates are 30% for UVAA members and 40% for non UVAA members. Entries must be original works of art and entirely created by the entrant. No work will be accepted into this show which is in violation of any copyright. Artwork must have been completed within the last two years. Work must not have been previously exhibited at UVAA.
